NOTING the Notice of 4 July 2008 in which we formally notified the Charged Person and his Lawyers that we were seeking to extend the provisional detention – the duration of which is due to expire on 31 July 2008 – and that they had 15 days to submit their observations (C3/I),

**NOTING** that no observations have been submitted by the Lawyers of the Charged Person within the stipulated 15 days time period,

CONSIDERING that that Closing Order in the present case is to be issued within the coming weeks, but not until after 31 July 2008,

CONSIDERING that the conditions set out under Article 63(3) are still met, since the reasons stated by the Pre-Trial Chamber in its Decision of 3 December 2007 remain valid,

FOR THESE REASONS,

**ORDER** extension of provisional detention for a maximum duration of one year, pursuant to sub-Rule 63(6)(a).
