1. **THE PRE-TRIAL CHAMBER** of the Extraordinary Chambers in the Courts of Cambodia (“ECCC”) notes “Ieng Sary’s Expedited Request to make submissions on the application of joint criminal enterprise liability in the Co-Prosecutors’ appeal against the Closing Order against Kaing Guek Eav ‘Duch’”, filed on 15 September 2008 (the “Request”);
2. The Pre-Trial Chamber finds that an expedited timetable for receiving responses to the Request from the Parties involved in case file **001/18-07-2007-ECCC/OCIJ (PTC 02)** is appropriate.

THEREFORE, THE PRE-TRIAL CHAMBER HEREBY DIRECTS:
