REQUEST

- On 8 November 2012 the Co-Prosecutors filed an immediate appeal of the Trial Chamber's decision concerning the scope of the trial in Case 002/001¹ ('the appeal'). On 13 November 2012 Counsel for Khieu Samphan issued a request for an extension of time to file its' response to the appeal within 15 days after notification of the French translation.² On 19 November 2012 Counsel for Ieng Sary and Nuon Chea filed their responses to the appeal.³
- 2. On 20 November 2012 this Chamber granted Counsel for Khieu Samphan an extension of time of 10 days to file their response to the appeal. Such extension is to commence after the notification of the French translation of the appeal.⁴
- 3. Article 8.4 of the Practice Direction on the filing of Documents before the ECCC⁵ directs that parties are only entitled to submit a reply to a response if there is to be no oral argument, in which case, it must be filed within five days of notification of the response. In this instance, the Co-Prosecutors request that this Chamber hold public oral argument on the appeal due to the importance of the issues being raised to all parties and the people of Cambodia.
- 4. If such oral argument is not required by the Chamber, the Co-Prosecutors request that it be allowed to file a joint reply to all 3 Defence responses commencing five days from the notification of the Khieu Samphan response in Khmer and one of the other two official ECCC languages. This will avoid repetitive filings on similar issues and will save unnecessary time spent drafting and translating three separate appeal responses.
