Mr. IENG Sary, through his Co-Lawyers ("the Defence"), hereby notifies the Pre-Trial Chamber, pursuant to the Pre-Trial Chamber's directions contained in the Scheduling Order, 1 that it intends to submit an oral Reply to the Co-Prosecutors' Response to IENG Sary's Appeal on Command Responsibility, filed 4 May 2010.<sup>2</sup> The Defence further sees no reason why this hearing should take place in camera,3 and requests that the hearing be held publically, as there is absolutely nothing of a confidential nature that need be discussed. Although the Co-Prosecutors have expressed the opinion that no oral hearing is necessary,<sup>4</sup> they have not expressed a wish that, should such a hearing be held, that it be held in camera. Furthermore, the Co-Prosecutors have agreed "that the public does benefit from open court proceedings before the ECCC..."5
