 - (1) Opening Statements: length and form (Rule 89 bis 1);
 - (2) Uncontested Facts: effect on trial presentation (Rule 80(3)(e));
 - (3) Documentary Evidence: objections, method of admission, witness statements (Rule 80(3)(d) and 87);
 - (4) Accused Presence During the Hearing: (Rule 81);
 - (5) Accused Testimony: order, length, questioning manner and time allocation (Rule 89 bis 2 and 90);
 - (6) Witness Testimony: number, order, length, questioning manner and time allocation (Rule 84 and 91);
 - (7) Civil Parties Testimony: order, length, questioning manner and time allocation (Rule 91);
 - (8) Objections: types and manner;
 - (9) Notice of Request to Recharacterize Charges in Indictment at Judgment to include:
 - (a) that an armed conflict is not required to prove a crime against humanity;
 - (b) rape as a crime against humanity;
 - (c) commission of crimes by the third form of joint criminal enterprise (Rule 98).
