**STATEMENT BY THE INTERNATIONAL CO-INVESTIGATING JUDGE
REGARDING ADDITIONAL CRIME SITES IN CASE FILE 004**

The Office of the Co-Investigating Judges has been seised of a Supplementary Submission regarding additional investigations in Case File 004. A number of crime sites under investigation in Case File 004 have yet to be made public. Pursuant to Internal Rule 21(1)(c), the International Co-Investigating Judge wishes to issue the following information about those sites:

ADDITIONAL SITES IN CASE FILE 004

A) BATTAMBANG PROVINCE

- *Thipakdei Security Office* and *Tuol Mtes worksite*, Thipakdei commune, Koas Krala Disitric , Battambang Province
- *Phnom Tra Cheak Chet* and *Along Vil Breng*, Ruessei Preah village, Chhnal Mean Commune, Koas Krala Disitric, Battambang Province
- *Sector 1 Security Office & Damnak Reang execution site*, Banan village, Kanteu commune, Banan District, Battambang Province

B) PURSAT PROVINCE

- *Tuol Seh Nhav Pits* and *Prey Krabau Killing Fields*, Rumlech and Khnar Totung communes, Bakan District, Pursat Province (*treatment of the Khmer Krom*)
- *Phum Veal Prison*, Talo commune, Bakan District, Pursat Province (*treatment of the Khmer Krom*)
- *Svay Chrum aka Phum Thkaul prison* and *Boeng Bat Kandal aka Trach Kraol Prison*, Boeng Bat Kandal commune, Bakan District, Pursat Province (*treatment of the Khmer Krom*)
- *Chanreangsei Pagoda Execution Site - Kaun Thnoat* or *Cham Village mass graves and wells*, Rumlech commune, Bakan District, Pursat Province (*treatment of the East Zone evacuees*)
- *Veal Bak Chunching execution site*, Sre Sdok commune, Kandieng District, Pursat Province (*treatment of the East Zone evacuees*)

C) TAKEO PROVINCE

- “*Prey Sokhon execution site*” and the “*Wat Ang Srei Muny Detention Centre*”, Sy Sla village, Thlea Prachum commune, Koh Andet District, Takeo Province (*treatment of the Khmer Krom*)
- *Slaeng village forest; Wat Angkun; Preil* and *Saom villages Execution sites & Wat So Ben prison*, Kok Prech and Kampeng communes, Kirivong District, Takeo Province (*treatment of the Khmer Krom*)

- **Wat Pratheat Security Center**, Kok Prech commune, Kirivong District, Takeo Province
(*treatment of the Khmer Krom*)
- **Kraing Ta Chan Security Center**, Tram Kak District, Takeo Province, (*treatment of the Khmer Krom and others*)

D) KAMPONG THOM PROVINCE

- The “**Colonial Prison in Kampong-Thom**”, Kampong Thom City, Kampong Thom Province
(*purge of the Central Zone*)

E) KAMPONG CHAM PROVINCE

- “**Thnal Bek execution site**”, Svay Teap commune, Chamkar leu District, Kampong Cham Province
(*in relation to Wat Baray Chan Dek Security Centre*)
