We order competent agents to arrest and bring the above-named person before us. Where, due to the circumstances, the person in question cannot be brought before us immediately after arrest, the person shall be placed in the ECCC detention facility and presented to us as soon as possible.

We request that all custodians of the public force to whom shall be shown this order shall, if needed, assist in executing this order.
