Duch \$3, male, born on 17 November 1942,

placed under examination for Crimes against humanity and grave breaches of the Geneva Conventions dated 12 August 1949, offences defined and punishable by Articles 5, 6, 29 (New) and 39 (New) of the Law on the Establishment of the Extraordinary Chambers in the Courts of Cambodia, dated 27 October 2004.

Notify the Charged Person and his lawyers that the duration of Provisional Detention stated in the order for Provisional Detention dated on 31 July 2007 will expire on 31 July 2008 and that we are seeking to extend that detention.
