We take note of the Decision rendered by the Supreme Court Chamber on 16 September 2012 ordering that the Accused Ieng Thirith be released and of the Order of the Co-Prosecutors of the same date to the Chief of Detention Facility of the ECCC to release leng Thirith immediately.

We also take note of the Decision rendered by the Phnom Penh Municipal Court of First Instance dated 14 September 2012 appointing Ieng Chivida, daughter of Ieng Thirith, as General Guardian of Ieng Thirith.

With reference to your letter of 16 September 2012 and paragraph 2 of Rule 25 of the Rules Governing the Detention of Persons Awaiting Trial or Appeal before the Extraordinary Chambers in the Courts of Cambodia, the Office of Administration of the Extraordinary Chambers in the Courts of Cambodia confirms that you, acting on behalf of the General Department of Prisons of the Minsitry of Interior of the Royal Government of Cambodia, may release the Accused IENG Thirith in accordance with the Supreme Court Chamber Decision dated 16 September 2012, and in compliance of the Order by the Co-Prosecutors, into the custody of the General Guardian appointed by the Phnom Penh Municipal Court.
