**THE SUPREME COURT CHAMBER** of the Extraordinary Chambers in the Courts of Cambodia:

**BEING SEISED** of the Co-Prosecutors' Immediate Appeal against Decision on Reassessment of Accused Ieng Thirith's Fitness to Stand Trial following the Supreme Court Chamber Decision of 13 December 2011 ("Immediate Appeal");<sup>1</sup>

**NOTING** the Defence's request that the Supreme Court Chamber holds an oral hearing prior to deciding on the Immediate Appeal in order for the parties to discuss in more details matters of facts and law;<sup>2</sup>

**CONSIDERING** that a hearing in this case may provide useful information for the determination of the Immediate Appeal by *inter alia* giving the Chamber the opportunity to hear the views of the parties on the conditions of judicial supervision proposed by the Co-Prosecutors and allowing it to enter into discussion with the guardian to the Accused, Ms. Ieng Vichida, who has been appointed by the Municipal Court of Phnom Penh on 15 September 2012;

**HEREBY SCHEDULES** a public appeal hearing to be held on Tuesday, **13 November 2012, at 9:30am**, in the main courtroom of the ECCC.
