NOTING the Trial Chamber's decision of 17 November 2011 ordering the release of the Accused, IENG Thirith, from the ECCC Detention Facility ("Release Order");¹

BEING SEISED of a request lodged by the Co-Prosecutors under Internal Rule 82(6) (Rev. 8) to stay such Release Order ("Request"), together with a copy of the Co-Prosecutors' appeal against such Release Order filed with the Greffier of the Trial Chamber ("Appeal");

CONSIDERING the seriousness of the crimes for which IENG Thirith is indicted, the disagreement between the judges of the Trial Chamber on the issue of conditions upon release, and that the Co-Prosecutors' Appeal is not manifestly unfounded;

PURSUANT to Internal Rule 82(6);

HEREBY:

GRANTS the Co-Prosecutors' Request;

ORDERS that the Trial Chamber's Release Order is stayed; and

ORDERS that the Accused shall remain in detention until the Supreme Court Chamber has handed down its decision on the Co-Prosecutors' Appeal.
