REQUEST

- 1. Pursuant to Internal Rules 92 and 87(4), the Co-Prosecutors request that the Trial Chamber place on the Case File the following attached material:
 - 1) Video interview with the accused Khieu Samphan (Annex 1).
 - 2) Book 'Behind the Killing Fields: A Khmer Rouge Leader and One of His Victims' by Gina Chon and Thet Sambath (**Annex 2**)
- 2. The interview with Khieu Samphan is relevant to ascertaining the truth of the allegations addressed in the first trial. It contains statements from Khieu Samphan relating to the historical background of the DK period, the roles and responsibilities of the Accused before, during and after the DK period, the structure of DK and the policies of the DK government including the policy relating to the forced transfer of the civilian population.
- 3. The interview was not available to the Co-Prosecutors before the opening of the trial on 27 June 2011. The video was posted online by a third party claiming to be Khieu Samphan and discovered by the Office of the Co-Prosecutors on 1 November 2011. In total it consists of eight hours and 24 minutes of footage, which appears to have been taken on two separate days. Khieu Samphan is the only person that appears on the screen, though the voice of an unidentified male interviewer can be heard putting questions to him.
- 4. The book by Gina Chon and Thet Sambath is based in large part on interviews with Nuon Chea. This book is also relevant to ascertaining the truth of the allegations addressed in the first trial. It contains statements from Nuon Chea relating to the historical background of the DK period, the roles and responsibilities of the Accused before, during and after the DK period, the structure of DK and the policies of the DK government including the policy relating to the forced transfer of the civilian population.
- 5. The Co-Prosecutors first became aware of this book on Wednesday 30 November 2011 in the ECCC library. The library had acquired the book in August 2011. The book was published in 2010. Consequently on Friday 2 December 2011 the Co-Prosecutors disclosed an electronic version of this book via email to the Trial Chamber and all the parties.
- 6. In the circumstances, the OCP was unable to include the video or the book in its last document list filed to the Trial Chamber on 1 November 2011 relating to those documents

to be put before the Chamber in the first 3 weeks of trial.¹ It is therefore requested that the Chamber places the video interview and book on the Case File.
