**SUBJECT:** Updated information regarding scheduling of proposed experts



Further to its Memorandum of 11 April 2012 regarding the scheduling of a number of proposed experts (E172/17), the Chamber provides the following updates to the parties regarding the dates on which the below proposed experts will be heard:

- David Chandler: from 16 to 23 July 2012 (allocated time for questioning by the Chamber and all parties: 5 days).
- Philip Short: from 1 to 8 October 2012 (6 days). The Court will sit on Friday 5 October 2012.
- Elizabeth Becker: on 17, 18, 19, 23 and 24 October 2012 (5 days). Due to the unavailability of this proposed expert on Monday 22 October, the Chamber will not sit on that day but will sit instead on Friday 19 October 2012.
- Henri Locard: from 5 to 7 November 2012 (3 days).

Despite having received from the Chamber the summaries of testimony provided by the parties, the proposed experts have requested further information to facilitate more effective preparation in advance of their testimony. The parties requesting the expertise of the above proposed experts are invited to provide them, through the Witness and Expert Support Section, with further particulars about the scope of their intended questioning. They are requested to do so by 4 June 2012 for the above proposed experts, and in the future for any other proposed experts that the Chamber may decide to hear.

The Chamber provides advance notice to the parties that it will examine the above proposed experts on all issues on which they are able to testify within the scope of the Case 002 Closing Order (see E188, paragraph 6 (in relation to David Chandler and Henri Locard) and E141 (noting that “directions to guide the required scope of expert testimony in relation to Case 002/1 will be provided by the Chamber where considered necessary”).
