REQUEST

- 1. As part of a routine review of the Office of the Co-Prosecutors' (OCP) document database, it has come to the attention of the Co-Prosecutors that the OCP is in possession of two different copies of the written record of the interview conducted by the University of London's School of Oriental and African Studies (SOAS) with witness TCW-504 on 25 July 2005. Only one of these copies, which contains a redaction, is currently on the Case File (D2-15.58). The second copy, which is saved in the OCP database, appears identical in substance to document D2-15.59, but is unredacted.
- 2. Consistent with the right of the Accused to receive all available prior statements of witnesses whose testimonies are proposed to be put before the Chamber, the Co-Prosecutors respectfully request that the unredacted version of the abovementioned SOAS Interview, attached as **Confidential Annex 1**, be placed on the Case File.
