THE TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia;

**BEING SEISED** of Case File No. 001/18-07-2007-ECCC/TC pursuant to the "Decision on Appeal Against the Closing Order Indicting Kaing Guek Eav Alias Duch," rendered orally by the Pre-Trial Chamber on 5 December 2008 and filed in Khmer on 9 December 2008;

**MINDFUL OF** the "Order Scheduling the Start of the Substantive Hearing and Sitting Days for the First Three Months" dated 23 February 2009;<sup>1</sup>

MINDFUL OF the "Direction on the Scheduling of the Trial" dated 20 March 2009;<sup>2</sup>

**MINDFUL OF** the "Decision on Protective Measures for Witnesses and Experts and on Parties' Requests to Hear Witness and Experts" dated 3 April 2009;<sup>3</sup>

**RECALLING** that the Substantive Hearing started on 30 March 2009;

**MINDFUL OF** the need to provide the Parties with sufficient notice of the future scheduling of the trial proceedings, including an indication of when witnesses and experts will be called to testify;

#### **HEREBY**

**ORDERS** that the scheduling of the Substantive Hearing for the period of 20 to 30 April 2009 will be as follows:

- "Issues relating to M-13" and "Establishment of S-21 and the Takmao Prison": from 20 to 23 April 2009. During this period, there will be questioning of witnesses Chan Voeun (KW-31) and Chan Khan (KW-32) on "Issues relating to M-13" and of the Accused on "Establishment of S-21 and the Takmao Prison";
- "Implementation of CPK Policy at S-21, including Choeng Ek": from 27 to 30 April 2009. During this period, there will be questioning of the Accused and of experts Craig Etcheson (KW-02) and Raoul Marc Jennar (D12);
