PRESS BRIEFING ON THE OPENING STATEMENTS IN CASE 002**

The Extraordinary Chambers in the Courts of Cambodia would like to invite both national and international media representatives for a press briefing on the upcoming Opening Statements and the Substantive Hearing in Case 002 on Sunday, November 20, 2011, at 3:00 – 4:30 pm at the Sunway Hotel.

The briefing is aimed at providing the press with background information on the ECCC and its signature case, concerning the four surviving leaders of the Khmer Rouge regime. Practical information on the court’s services for the media will be also presented during the briefing. ECCC Media Accreditation Cards will be handed out to those who have requested them.

The briefing will be conducted in English only and no translation will be provided during the session. However, briefings in Khmer, French and Japanese will be also available after the formal session as all spokespeople of the Public Affairs Section of the court will be at present.
