**APPEAL HEARING IN CASE 001 SCHEDULED FOR 28 – 31 MARCH 2011**

The Supreme Court Chamber of the Extraordinary Chambers in the Courts of Cambodia (ECCC) has scheduled an appeal hearing in Case 001 against Kaing Guek Eav alias Duch as follows :

**Monday 28 March 2011**

09:00-16:30 Thematic session 1 (Personal Jurisdiction)

**Tuesday 29 March 2011**

09:00-16:40 Thematic session 2 (Crimes against humanity) and Thematic session 3 (Sentencing)

**Wednesday 30 March 2011**

09:00-16:30 Thematic session 4 (Civil Parties' appeals)

If the hearings cannot be completed within the time frames above, they will continue on Thursday 31 March.

Kaing Guek Eav alias Duch was convicted for crimes against humanity and grave breaches of the Geneva Conventions of 1949 and sentenced to 35 years of imprisonment by the Trial Chamber on 26 July 2010. His sentence was reduced with 5 years as a remedy for the period the Accused had been unlawfully detained by the Cambodian Military Court prior to his transfer to the ECCC.

The Supreme Court Chamber will hear appeals filed by the Co-Prosecutors and the Accused, and by Civil Parties.

**Media Accreditation for the appeal hearing:**

Advance registration and accreditation is required for all media representatives who wish to be granted access to the ECCC on 28 – 31 March 2011. The following procedure will apply for media representatives seeking access to the ECCC for the appeal hearing:

- a) Media representatives currently holding a valid ECCC accreditation card must register their request for access to the appeal hearing with the Public Affairs Section by sending an email to [PAS@ECCC.GOV.KH](mailto:PAS@ECCC.GOV.KH).
- b) Media representatives currently holding an expired ECCC accreditation card must re-submit a Completed and signed Media Accreditation Form ([http://www.eccc.gov.kh/english/cabinet/fileUpload/26/ECCC\\_Accreditation\\_Media\\_Application\\_Form.doc](http://www.eccc.gov.kh/english/cabinet/fileUpload/26/ECCC_Accreditation_Media_Application_Form.doc)) together with their request for registration to [PAS@ECCC.GOV.KH](mailto:PAS@ECCC.GOV.KH). Please indicate the card number on your expired ECCC accreditation card.
- c) Media representatives who have not previously been accredited to the ECCC must submit a Completed and signed Media Accreditation Form ([http://www.eccc.gov.kh/english/cabinet/fileUpload/26/ECCC\\_Accreditation\\_Media\\_Application\\_Form.doc](http://www.eccc.gov.kh/english/cabinet/fileUpload/26/ECCC_Accreditation_Media_Application_Form.doc)), a jpg portrait photo and copy of passport together with their request for registration to [PAS@ECCC.GOV.KH](mailto:PAS@ECCC.GOV.KH)

30 seats in the public gallery of the courtroom have been reserved for representatives of the media. Priority will be given to print media. The remaining media representatives will be accommodated in the media room on the ground floor. Media representatives who wish to be allocated a seat in the public gallery should submit a request for this together with their registration for attendance of the hearing.
