We acknowledge receipt of you Letter<sup>5</sup>, dated 31 March 2010, requesting “an extension of the set deadline to 1 (one) month, i.e. until 31 May 2010” to file supplementary information in relation to initial civil party applications filed with the Victims Support Section.

In support of your request you refer to our decision dated 26 March 2010<sup>6</sup> granting a one month extension to the Victims Support Section to file all pending civil party applications with the OCIJ.

It is important to recall that civil party applicants were authorized to file supplementary information<sup>7</sup>, if relevant, in light of the Co-investigating Judges’ Statement concerning the scope of the investigation in Case File 002, on 5 November 2009. This opportunity is

unrelated to the filing of Victims Information Forms by the Victims Support Section with the Office of the Co-Investigating Judges.

Consequently, the extension of the deadline for the Victim Support Section to file all pending civil party applications with the OCIJ is independent from the opportunity for the civil party applicants to file supplementary information. Therefore, the deadline set in the Interoffice Memorandum dated 27 January 2010<sup>8</sup> will remain in force.

Nevertheless, we take due note of the importance for all Civil Party Lawyers to have access, as soon as possible, to the Victim Information Form and any supporting documents as well as the Victims Unit Individual report (containing a summary in English of the alleged criminal acts) as soon as it available in respect if clients for whom the lawyers have provided powers of attorneys to VSS. That is why we have recently authorized the Victims Support Section to provide the relevant files to the designated lawyers of the applicants, regardless of whether the application has already been placed on the Case File.
