

THE PRE-TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia ("ECCC") is seized of an "Appeal against the [Co-Investigating Judges]' Order rejecting Request for a Second Expert Opinion," ("Appeal")¹ filed on 30 April 2010 by the Co-Lawyers of the Charged Person Nuon Chea against the Co-Investigating Judges' "Order Rejecting Request for a Second Expert Opinion (Nuon Chea's Twenty-Sixth Request for Investigative Action)" ("Order")² of 1 April 2010.

The Pre-Trial Chamber has determined the final disposition of the Appeal, which it hereby pronounces. A reasoned decision in respect of the Appeal shall follow in due course.

THE PRE-TRIAL CHAMBER HEREBY DECIDES UNANIMOUSLY:

- 1. The Appeal is admissible in so far as it relates to the request for appointment of an additional expert to re-examine the existing expert report. It is otherwise inadmissible;
- 2. That part of the Appeal which was found admissible is dismissed on merit.

In accordance with Internal Rule 77(13), this decision is not subject to appeal.
