

INTRODUCTION AND ARGUMENT


1. On 27 August 2009, the Trial Chamber issued a Direction on Proceedings Relevant to Reparations and on the Filing of Final Written Submissions (E159). In this Direction, the Trial Chamber decided to schedule the hearing of the Closing Statements on 23 November 2009.
2. Prior to this Direction, the National Co-Prosecutor had already planned a mission abroad, from 23-27 November 2009. This mission being of the highest importance cannot be postponed.

REQUEST

3. Therefore, the Co-Prosecutors request the Trial Chamber to grant a postponement of that hearing till 30 November 2009, in order to allow the National Co-Prosecutor to attend the hearing of the Closing Statements.
