**THE TRIAL CHAMBER** of the Extraordinary Chambers in the Courts of Cambodia;

**SEISED** of Case File No. 002/19-09-2007-ECCC pursuant to the Decisions on Appeal against the Closing Order by Nuon Chea, Ieng Sary, Ieng Thirith and Khieu Samphan,<sup>1</sup> rendered by the Pre-Trial Chamber on 13 January 2011;

**NOTING** the applications by the Defence Team of KHIEU Samphan for access to the Detention Facility of the ECCC and to the Case File 002 (“Motions”)<sup>2</sup>;

**RESPONDING** both to the Motions and setting out procedures of general application to all Defence teams;

**PURSUANT TO** Rule 85 of the Internal Rules and Rule 9 of the Rules Governing the Detention of Persons Awaiting Trial or Appeal before the Extraordinary Chambers in the Courts of Cambodia (“Detention Facility Rules”);

**HEREBY**

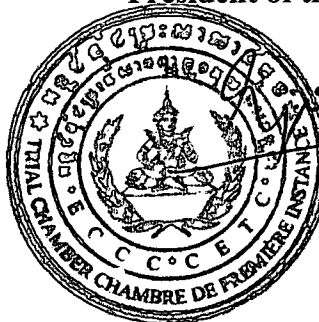
**DIRECTS** that, pursuant to Rule 9.18 of the Detention Facility Rules, members of the Defence Teams shall be allowed access to the Accused at the Detention Facility.

The Defence Support Section shall immediately inform the Chief of the Detention Facility, through the Detention Liason Officer, of any new member joining the Defence Team or of any member departing from the Team. The Trial Chamber Greffiers shall be copied in such communications. The Chief of the Detention Facility shall then grant access in accordance with the Detention Facility Rules.

**FURTHER DIRECTS** that new members of the Defence Teams shall make a request to the Trial Chamber Greffiers using the appropriate forms made available by the Court Management Section for access to the relevant case file through ECCC Zymage Portal and filing notification.

Current members of the Defence Teams will retain their access rights to the Case File. The Defence Teams shall immediately inform the Greffiers of the Trial Chamber of any member departing from the Team so that access can accordingly be revoked. *Nur*
