Mr. IENG Sary, through his Co-Lawyers (“the Defence”), hereby requests to file his Rule 89 preliminary objections in English by the filing deadline with the Khmer translation to follow as soon as practicable. This Request is made necessary because the Interpretation and Translation Unit has informed the Defence¹ that it cannot translate the Defence’s preliminary objections by the 14 February 2011 filing deadline.² The two DSS translators have also informed the Defence that they will be unable to assist in the translation of these preliminary objections. The Defence has no capacity to perform the translations on its own.

WHEREFORE, for all the reasons stated herein, the Defence respectfully requests the Trial Chamber to accept the filing of the Defence’s Rule 89 preliminary objections in English by the filing deadline with the Khmer translation to follow.
