1. On 17 January 2011, the Trial Chamber considered itself seized of Case 002, and indicated in the 'Order to File Material in Preparation for Trial'¹ (**Order**) that the parties have to file their witness lists in accordance with Internal Rule 80. Whilst the defence contends that the Pre-Trial Chamber's Decision² should not be considered as a 'decision' within the meaning of Internal Rule 77(14), the Order specified that the time-limits started running from 14 January 2011.³
2. The defence for Madame Ieng Thirith (**Accused**) herewith files its Witness List with the Trial Chamber, in accordance with abovementioned Order. The names of witnesses already submitted by the Co-Prosecutors on the OCP Witness List⁴ are omitted from this list to avoid duplication.
3. If the Chamber or the OCP at some stage intends to withdraw certain witnesses mentioned on the OCP Witness List, the defence submits it should be consulted as to whether it finds these witnesses of relevance to the defence case.
4. The defence also reserves the right to amend its Witness List to call as witnesses authors of documents and exhibits submitted in due course by the Co-Prosecutors and other parties, the contents of which may be contested by the defence.
5. The attached confidential annex contains the names of witnesses and expert proposed by the defence for the Accused.
